# Rules & Regulations

#### Terms of Business:

Generally in accordance with standard British Marine Federation (BMF) standard berthing, mooring and/or storage ashore licence for vessels at marina or boatyard and terms of business are available upon request from the office, together with the conditions below:

# **Payment Terms:**

Payment in advance. Falmouth Boatyard reserves the right to alter the rates without prior notice. Please note to qualify for the winter storage rate 4 months storage and cradle hire is charged in advance. We reserve the right to delay relaunch until payment in full has been received. Late payments will incur interest at 3% above BoE base rate. We reserve the right to remove credit facilities if credit terms are not adhered to.

## Concrete Hardstanding:

The concrete hardstanding occupied by your boat must be kept clean and tidy and at the end of the storage period returned to its original condition. Any damage caused, staining from oil, antifouling, paint and other substances must be removed. FBY reserves the right to clean any area not left in its original condition and charge for this service. We suggest sheeting your area whilst carrying out work which could lead to damage or staining.

# **Planning Conditions:**

There are planning conditions which apply to the site & must be observed by all customers.

#### i) Use of Power Tools

The period during which the maintenance of any laid up boats which involve the use of power tools or other tools which would generate a noise audible 10 metres from any boat shall be restricted to:08.00 to 19.00 Monday to Friday and 10.00 to 17.00 Saturday, Sunday and Easter and May Bank Holiday and not at all on other BankHolidays.

# ii) Boat Lay up

Boat lay up is available from 1 October to 22 May.

A limited amount of lay up is available outside these dates by prior arrangement iii) Halyards/Running Rigging

Customers must secure running rigging, hallyards etc to prevent noise and nuisance to nearby residential property.

### Work on Vessels:

Other than work carried out by owners, members of their family or regular crew, no contractor may work on a vessel for reward without the prior written consent of Rustler Yachts Ltd which will normally only be given to resident contractors registered with the company. Contractors will have to provide current relevant insurance cover, agree to comply with Health and Safety at Work Act and provide evidence of their competence.

#### Sale of a Vessel:

a) In the event that the customer wishes to arrange a sale otherwise than through Rustler Yachts or its approved broker, he shall:

-be present at all times when the vessel is being viewed;

-provide us with details of any offer for sale on request;

-not display a notice of sale on the vessel or within our premises.

b)In the event of the sale of the vessel otherwise than through Rustler Yachts or its approved broker, the customer undertakes to pay, or to ensure that any agent involved in the sale will pay, to us a commission of 1% of the gross selling price.

### **Electricity:**

All boats are metered, and readings are taken on a weekly basis. Customers are responsible for monitoring their electricity consumption.

# Cradles:

FBY reserves the right to insist that customers use cradles where propping is considered unsafe. Customers must not adjust or tamper with any cradles or props.

# Dodgers, Sails etc:

All dodgers, sails, particularly furling sails etc... must be removed from boats in storage to reduce wind factor as much as possible.

#### Water:

Water on site is free but please note that it is NOT suitable for drinking.


